● **General Environmental Management Consulting**

Nigeosafe Consult Limited provides general environmental resources management and compliance consulting to put our clients on top of the game, we ensures that our clients maintain an appropriate measure of compliance with environmental regulations and carry out their businesses in an environmentally sustainable and friendly manner. ● **Environmental Impact Assessment (EIA)**

Environmental Impact Assessment (EIA) is a decision making tool geared at identifying, predicting and evaluating the environmental effects of proposed projects, developments and programmes taking into account the significant environmental consequences thereof. The study also identifies appropriate enhancement, mitigation and control measures, further from the decision to proceed.

● **Post Impact Assessment (PIA)/Environmental Evaluation Report**

PIA/EER study is carried out post-commissioning of a project. It is carried out taking into account the recommendations of an EIA study to determine environmental conditions following an impact on the environment. As well as the study providing the extent of degradation, it also provides tools for decision-making with regards to remediation

● **Environmental and Social Due Diligence (ESDD)**

ESDD is the assessment of the environmental impacts of a project also taking into account its social implications. This study is carried out on projects to determine the level of financial sustainability of the project. Factors to be investigated and assessed during study include the potential land contamination, health and safety regulations, climate change, sustainability and carbon footprint. Conducting ESDD on transactions is a critical component of a

financial institution's E&S Management System and its outcome should be factored in to the decision-making process for proceeding with the transaction.

● **Environmental Site Assessment (ESA)**

Environmental Site Assessment is a report prepared for a real estate holding that identifies potential or existing environmental contamination liabilities. The analysis, typically addresses both the underlying land as well as physical improvements to the property. The process is carried out in 3 phases.

● **General Desktop Studies**

This service is carried out by drawing on literature reviews and field surveys as may be required. The study gathers and analyses existing data from public domain, scientific and commercial databases, and available project sources.

The feedback is designed to inform environmental surveys, permits and consents, EIA activities etc. The study identifies risks and opportunities at an early stage prior to commitment of costly resources. Desktop studies are extremely effective tools that inform planning any environmental project.

● **Environmental Compliance Management**

This is the continuous monitoring of a client's compliance to all environmental statutory requirements as mandated by Regulators. This requires periodic monitoring of facilities to ensure required environmental parameters are not violated. Furthermore, alongside Environmental Audits, we ensure all required reports and documentation are kept up to date as required alongside providing the appropriate advice on environmental and other management issues.

● **Environmental Technology (Equipment Rental)**

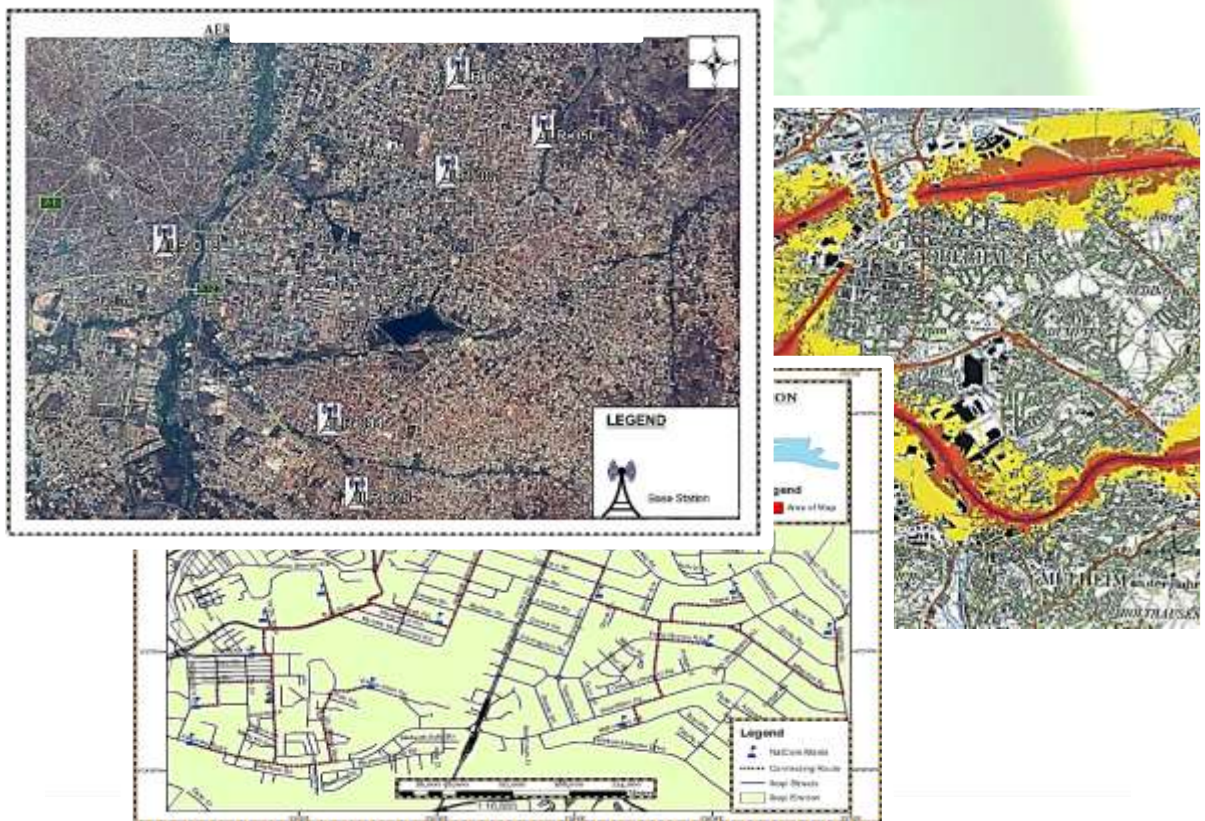
● Noise Mapping

Social Impact Assessment Studies

NCL carry out Social Impact Assessment for both proposed and exiting infrastructural developments. In the light of different reactions from project neighbouring communities, it is so vital to carry out social impact assessment of any developmental project. This type of study is a proactive measure to forestall social liability which could include protest, social unrest, company closure, litigations, financial and reputational risk. This study identifies potential areas of social risks and prefers solutions and mitigations to ameliorate and or eliminate them.

Environmental Sensitivity Index (ESI)

One of our new areas of expertise in Nigeosafe Consult Limited is Environmental Sensitivity Index mapping commonly used in oil spill evaluation, prevention, and clean up processes. We measure the coastal zone natural resources and classify them in numeric characterization on the level of sensitivity. We map wildlife of all types based upon known habitats, locations, and seasonality.

● **Environmental and Socio-economic Baseline Surveys**

NCL have team of well experienced professionals who are equipped to carry out and establish the baseline level of potential contaminants in soil and groundwater beneath a project/study site and to assess the extent of contamination of a proposed project site.

In this type of survey, we document existing environmental and social conditions and determine the potential for present and extent of past site contamination e.g., hazardous substances, petroleum products, and derivatives, and identifies potential vulnerabilities to include occupational and environmental health risks.

● **Operational Safety Case Documentation**

A Safety Case is a structured argument, supported by evidence, intended to justify that a system is acceptably safe. Safety cases are often required as part of a regulatory process, a certificate of safety being granted only when the regulator is satisfied by the argument presented in a safety case.

● **Waste Management Auditing**

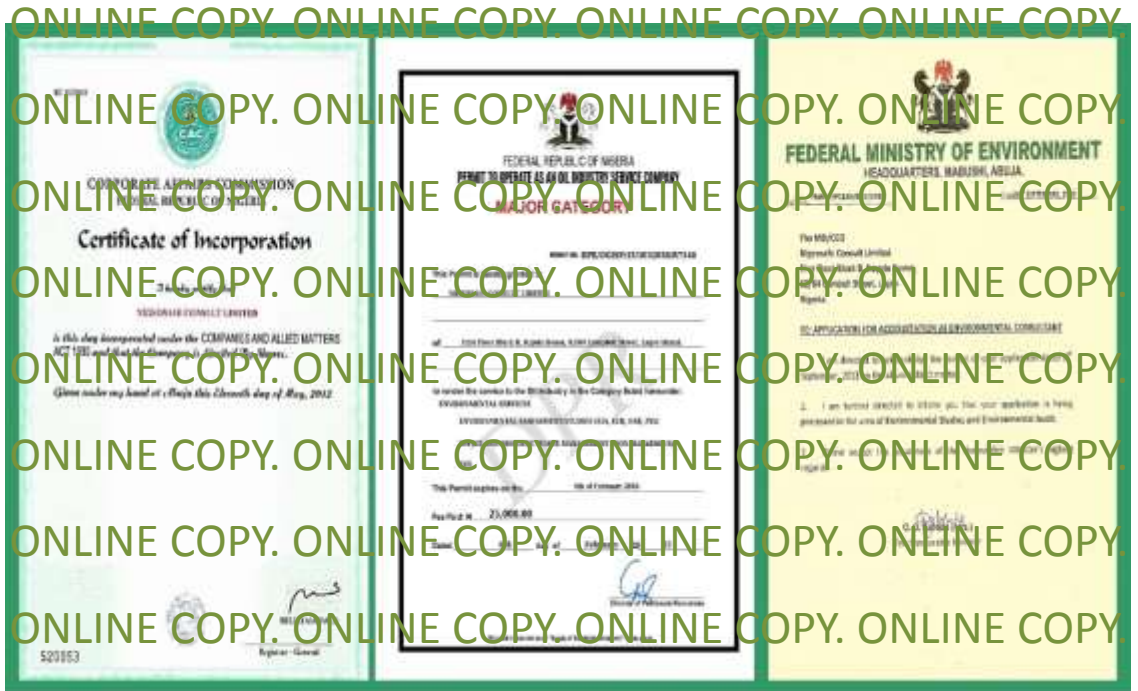
